- I. Meeting was called to order at 10:06 AM by Terry Gordon and proper notice was acknowledged. Board members present were Terry Gordon, Mike Matthews, Sam Matthews, Annie Rand, Peter Asmus and Lisa Bieringer
- II. Meeting minutes from January 5, 2019. Terry Gordon asked if there were any corrections required for the January meeting minutes. No corrections requested. Terry Gordon made a motion to adopt meeting minutes. Motion passed.

Sam Matthews made a motion to approve the slate of candidates with the exception of the Member-at-large position, which would be voted on separately. The meeting attendees voted and the slate was elected. The qualifications for the Member-at-large position were discussed, SBVA membership being a requirement. It was determined that Patrick was not a member so he could not run for the 2019 term but was encouraged to become a member and run for the 2020 term.
    - c. Annie Rand called for a vote to elect Lisa Bieringer as the Board's Member-at-large. The meeting attendees voted and Lisa was elected.
    - d. Proposed Amendments to the Bylaws.
      - i. The proposed amendment to modify the requirements for nominating and electing board members was shared with the attendees. It was determined that the amendment would be voted on during the March 2, 2019 meeting.
      - ii. Chris Harrington shared information on the Stinson Beach Affordable Housing Committee and inquired about the SBVA becoming a fiscal sponsor. Members asked questions. There was a discussion about the proposed structure of the relationship between SBVA and SBAHC and the accounting practices. It was determined that the amendment would be voted on during the March 2, 2019 meeting.
